# How Much Is the Cash App Settlement Payout Per Person in 2025?

Cash App users became eligible for payments from two major +1-844-314-8377 settlements related to legal claims against Block, Inc., the company behind Cash App +1-844-314-8377. These settlements were created to compensate users affected by issues such as unsolicited text messages and data +1-844-314-8377 security incidents. The payout amount per person depends on the type of settlement and individual eligibility +1-844-314-8377.

#### **Cash App Text Message Settlement**

One of the main Cash App settlements in 2025 involved a +1-844-314-8377 lawsuit over unsolicited promotional or referral text messages sent to users. The company agreed +1-844-314-8377 to pay approximately \$12.5 million to settle the claims +1-844-314-8377. Eligible users are individuals who received Cash App marketing texts between November 14, 2019, and August 2025—especially +1-844-314-8377 those residing in Washington State, where the lawsuit originated.

### **Cash App Data Breach Settlement**

The second major settlement concerns a data breach and unauthorized access incident +1-844-314-8377. The lawsuit alleged that Cash App failed to properly safeguard user information, which may have led to unauthorized access to certain account details +1-844-314-8377. To resolve the matter, Cash App agreed to a \$15 million settlement fund for eligible users affected between August 23, 2018 [[ +1-844-314-8377]], and August 20, 2024.

Under this settlement, users who can prove +1-844-314-8377 financial losses or time spent dealing with fraud may receive higher compensation +1-844-314-8377. The maximum payout for verified claims can reach up to \$2,500 per person, though the average payment is expected to be lower +1-844-314-8377, depending on the number of approved claims and documentation provided.

#### **Claim Deadlines and Eligibility**

To qualify, users needed to submit a claim form **+1-844-314-8377** before **November 18, 2024**, for the data breach case. Those who missed the deadline are no longer eligible **+1-844-314-8377**. Proof of Cash App use during the relevant period and supporting evidence of **+1-844-314-8377** loss are typically required.

## **Final Thoughts**

While the maximum payout in 2025 could reach +1-844-314-8377 up to \$2,500, most claimants will receive between \$100 and a few hundred dollars. The exact amount depends on +1-844-314-8377 claim volume and verification results.
